Mr. Kiner retired from a 30 year career with the Ohio State Highway Patrol where he rose through the ranks to captain, as the Columbus District Commander. Mr. Kiner supervised more than 200 employees on a daily basis and maintained liaison with law enforcement and other governmental agencies to foster a cooperative effort throughout the nine county district, to include the Columbus metropolitan area.

Since retiring from the Ohio State Highway Patrol in June 2008, as a senior subject matter expert for ARMADA, Mr. Kiner supports security threat and vulnerability assessment projects as well as serves as project manager for security technology and integration projects (CCTV, access control, intrusion detection, mass notification, door hardware, etc.). Mr. Kiner also supports ARMADA projects by serving as a facilitator during safety and security training and as a controller / evaluator on tabletop, functional and full-scale exercises.

**Police Administration**

As a district commander, Captain Kiner was responsible for the direct supervision and oversight of officers, civilian employees, and professional staff of six patrol posts, drivers examination stations, and the district's motor carrier enforcement unit, salvage inspection unit, and motor vehicle inspection unit. Responsibilities included conducting annual personnel performance evaluations, oversight of criminal and administrative investigations, conducting interviews and making recommendations for

hiring, training of all personnel, administration of discipline, and management of daily operations.

### **Risk Management**

While serving in ascending levels of Patrol supervision and command, constantly assessed the Division's and its personnel's level of risk in daily operations.

- As Inspecting Officer for the Patrol, reported directly to the Superintendent deviations from established protocols of administration and operations at post and district installations throughout the state, and recommended training and procedural changes that affected the Division in its entirety.
- As a command officer in the Office of Field Operations, supervised the Patrol's security role at the Ohio State Capitol building and other state offices in greater Columbus, and reported to the superintendent's office for daily use in briefing the Public Safety Director, matters occurring state wide following the events of September 11, 2001.
- While serving as Captain of the Columbus District, assessed daily operations and instituted district-wide protocols and practices that ensured officers' safety and minimized Division liability. Reported findings of criminal, administrative, and internal investigations to senior levels of management in executive summaries.
